 Senior advisors or partners embedded in the UAE's financial free zones, with relationships across the fintech investment community and a clear pathway to compliant engagement.

SPV STRUCTURE

- Jurisdiction:** SPV established under ADGM or DIFC frameworks depending on the lead's preference and investor base.
- Governance:** The SPV Manager (Syndicate Lead) retains voting rights on the underlying shares, simplifying corporate governance.
- Settlement:** Digital stock and SPV unit certificates issued to investors within five business days of cleared funds.
- Close cadence:** Rolling close executed in monthly batches, minimizing legal costs at scale.
- Governing law:** State of Delaware, USA. Dispute resolution via AAA arbitration in New York, enforceable in the UAE under the New York Convention.

EQUITY & CARRIED INTEREST

Equity retainer vesting monthly over 6 months, 3-month cliff. 50% vest immediately at cliff; remainder monthly through month six.

20% Carry

Standard carry on the SPV. You participate in upside — not only fees earned at close.

Additional equity grants vest at \$2.5M and \$5M closed.
